
Grease Interceptor Inspection

Restaurant Inspection – Some Items to Consider

- Disposal of fats, grease, and oils
- Maintenance of grills, range, and exhaust hood
- Disposal of mop water and rinsing of floor mats
- Storage of cleaning supplies
- Spill cleanup methods
- Condition of dumpster and tallow bin or grease drum and drainage of dumpster area
- Condition of outdoor area including parking lot and stormdrains
